9. BOARD MEMBER/COMMITTEE REPORTS

A. Curriculum – Mrs. Kulesa, Chair

Mrs. Kulesa reported the Curriculum Subcommittee met on February 6, 2013. The following items were addressed: (a) Elementary Report Card – The report cards for grades K-5) were revised to align subjects to the Common Core State Standards in Math for all grades and in Literacy for grades K-2. Technology and 21st Century Skills were also added to the report card. Social Studies and Science will need to be updated as new standards are published. A copy of the report card will be forwarded to Linda Yoder with inquiries about report cards for students with IEP's.; (b) K-5 Math Fluency Philosophy and Expectations – K-5 Math Fluency Targets and Expectations were presented and will be posted on the website.; (c) K-5 Technology Expectations – K-5 Technology Expectations have been created and teachers are using the labs with the students on a regular basis. Students are using *Type to Learn* in grades K-5. (d) Writers Workshop – The implementation of a Writer's Workshop will be implemented at the elementary schools next year. This is a framework for teacher writing. Mentor texts have been purchased for Kindergarten and more mentor texts will be purchased to support the implementation of Writer's Workshop.

B. Facilities – Mr. Engle, Chair

The Finance Subcommittee met prior to the Board Meeting and reviewed the accounts by facilities report for the month of January and will forward the same to the Town of Plymouth Board of Finance.
