1. CALL TO ORDER

Mr. Engle called the meeting to order at 6:35 p.m.

2. ADOPTION OF THE AGENDA

3. DISCUSSION REGARDING MEMORANDUM OF AGREEMENT FOR ADMINISTRATORS AND THE CONTRACT FOR THE DIRECTOR OF TECHNOLOGY

Ms. Cruz explained to the Board Members when the contract was written for the administrators, the wording with respect to annuity was not written according to the IRS/TRB language. Therefore, she is requesting that the Board approve a Memorandum of Agreement correcting this error. After a brief discussion, the following motion was made:

Ms. Cruz then explained the contract for the Director of Technology. The entire section on annuity is very sparse. It does not address pre-tax, tax shelter annuity or what is allowable by law. After a brief discussion, the following motion was made:
